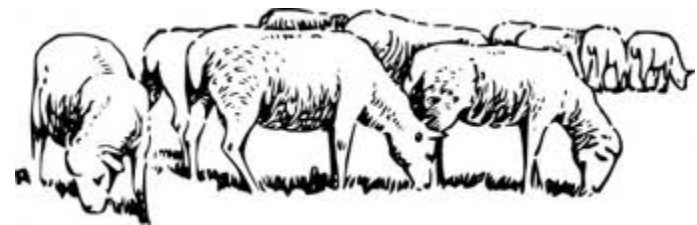

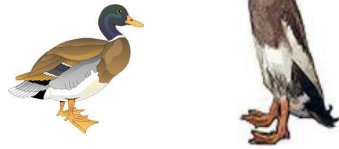

(The same dog may not be awarded High in Trial **and** Reserve High in Trial)

- 2nd Red Ribbon and a dog toy
- 3rd Yellow Ribbon and a dog toy
- 4th White Ribbon and a dog toy
- 5th Pink Ribbon and a dog toy

All qualifiers will receive a green qualifying ribbon and a Holiday treat bag.

**Notice to Exhibitor**

A separate entry must be made for each dog.

ALL DOGS MUST BE ON LEAD, except when being judged in the arena.

Please CLEAN UP AFTER YOUR DOG AND YOURSELF.

Entry acknowledgements will be E-Mailed before the trial if received before then. Trial Secretary will contact you immediately if the trial fills and a waiting list is started. If you want to be notified by USPS mail please include a self addressed envelope with postage.

Entry fee will not be refunded in the event that a dog is absent, disqualified, excused by the judge, or barred from competition by action of the test/trial committee. Entry fees will not be refunded if the test/trial cannot open or be completed by reason of riot, civil disturbance, fire or act of God, public emergencies, act of public enemy, strike or any other cause beyond the control of the club.
